Providing information and services for different groups with diverse needs and languages (i.e. Francophone Newfoundlanders and Labradorians, Aboriginal communities)


Keeping aware of and addressing differences in culture with different groups and in different geographic areas of the province

ther Challenges - Reaching Youth

How do we connect with youth to provide information?

How to we hold their attention?

How do we keep up with quickly changing technology and media, which brings new risks and challenges?



LIAN's Approach

Mixture of programs and forums to provide information Connection with schools and community groups

Online information and in-person presentations, camps, workshops

Trying to reach youth in rural areas

nti-Bullying Presentations

Roughly 50 presentations of 'The Legal Implications of Bullying' since 2007, to approximately 3,425 students (all on an ad hoc basis, as requested by schools)

Mainly presented to high school and junior high students in St. John's and surrounding area



nti-Bullying Presentations

Unique approach: not focused on why bullying is wrong, but on the legal/criminal consequences of bullying.

Focuses on potential criminal charges, the *Youth Criminal Justice Act*, effects of having a youth record

Positive feedback from teachers and administrators dealing with bullying issues

outh Justice Camps

Offered annually since 2000, plus additional camps where funding allows (this summer we will offer our 35th!

Aimed at youth between 12 and 15

Focus on crime prevention:

- Presentations by police, lawyers, judges, other justice personnel
- ▶ Field trips to police station, courthouse, etc.
- ▶ Mock trial held in court

outh Justice Camps





outh Justice Camps

- Particular focus on at-risk youth
- Collaboration with community organizations and community centres for youth in St. John's
- Previous camps have been held in other locations outside St. John's, including Conne River and several in Labrador. We've also offered an entirely Francophone camp

Financial challenges:

- ▶ Camp is offered completely free of charge to participants
- ▶ Travel costs to provide youth in different parts of the province with the opportunity to participate

nline Resources for Youth

Ideal for youth we can't reach through in-person presentations, camps or school visits

Dedicated section of our website with:

- ► Information on camp
- ► Access to publications on youth criminal justice, careers in justice, other information
- ► Links to other resources and frequently asked questions

rojects with Mixed Media

'My Parents Live Apart' publication - hard copy and electronic format

Focus groups with youth on language used, layout, graphics, etc.

Information for youth with parents going through separation/divorce

Explains terms, processes, and frequent questions related to family law and separation/divorce

rojects with Mixed Media

Supplemented by short videos, posted to YouTube and our website, with shorter versions of information included in the publication

Sustainable information, can be accessed throughout the province and by people who did not see the publication

ew Project: Healthy Relationships orkshops for Aboriginal Women and Girls

Series of eight workshops aimed at different Aboriginal populations in Newfoundland and Labrador

Focuses on intersection of two particularly marginalized groups - Aboriginal women

Providing legal information related to violence prevention and response (i.e. emergency protection orders, peace bonds, court processes), as well as recognizing signs of unhealthy relationships and potential violence

ew Project: Healthy Relationships orkshops for Aboriginal Women and Girls

Information on cyber-safety and online sexual exploitation

Based on consultations with Aboriginal leaders in different communities

Curriculum adapted to specific needs addressed in each community - not a 'one size fits all' project

he Way Forward

Collaboration with like-minded organizations (especially violence prevention groups across the province)

Consultation with local partners and community groups to understand needs of specific communities

Contact with teachers, guidance counsellors, youth workers to stay on top of emerging trends for youth - i.e. how is bullying taking place, changes in use of technology
